

RESOLUTION NO. 11-06

SALE OF UNNEEDED PERSONAL PROPERTY

WHEREAS, the City of Dadeville, Alabama, has certain items of personal property which are no longer needed for public or municipal purposes; and

WHEREAS, Section 11-43-56 of the Code of Alabama of 1975 authorizes the municipal governing body to dispose of unneeded personal property;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DADEVILLE, ALABAMA AS FOLLOWS:

SECTION 1. That the attached list (ATTACHMENT NO. 1) of personal property owned by the City of Dadeville; Alabama, is not needed for public or municipal purposes:

SECTION 2. That the Mayor and City Clerk be, and they hereby are, authorized and directed to dispose of the personal property owned by the City of Dadeville, Alabama, described in Section 1, above, by receiving bids for such property. All such property shall be sold to the highest bidder, provided, however that the Council shall have the authority to reject all bids when, in its opinion, it deems the bids to be less than adequate consideration for the personal property.






