

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dadeville, Alabama as follows:




SECTION 2. That Joe Smith, in his capacity as Mayor, is hereby authorized and directed to execute and manage said contract on behalf of the City of Dadeville.
