

Board Resolution to Provide Water Improvements.doc 27K

RESOLUTION NO. 13-17

WHEREAS, KwangSung America, LLC has committed to expanding their current operations at the William Thweatt Industrial Park and commits to creating 100 jobs at within one year after completion of their expanded facility within the City of Dadeville; and

WHEREAS, in order to create the jobs, SJA, Inc. requires water and sewer extension to fulfill the requirements of the new facility; and

WHEREAS, the City of Dadeville desires to assist this much needed creation of jobs and to apply for assistance to the Alabama Department of Community Affairs (ADECA) for a Community Development Block Grant (CDBG) Economic Development grant in the amount of \$350,000.00 to finance the infrastructure construction of the above described improvements; and

WHEREAS, a preliminary cost estimate attached hereto estimates total project costs to be \$497,700 for both water and sewer improvements which would require matching funds in the amount of \$147,700; and

WHEREAS, this amount is too high for the City to afford without help and so negotiations with the Waterworks and Sewage Board of the City of Dadeville have resulted in their agreement to provide water improvements outside the grant project budget lowering overall grant project costs to \$383,000 and

WHEREAS, the Waterworks and Sewage Board of the City of Dadeville will commit to completing all water improvements with \$22,000 from the City to assist with the purchase of materials and to be wholly responsible for paying expenses for any cost overruns on the <u>water</u> portion of the economic development KwangSung expansion project which will lower overall costs for the grant project to the construction of sewer only; and

WHEREAS, this change is acceptable to ADECA,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dadeville, Alabama as follows:

<u>SECTION 1</u>. That the City of Dadeville, Alabama makes application to the Alabama Department of Economic and Community Affairs for an Economic Development Fund Infrastructure CDBG grant for \$350,000.00 to assist with the financing of sewer improvements only.

<u>SECTION 2.</u> That the City of Dadeville will provide matching funds in the amount of \$33,000 as is required per the attached cost estimate and to provide funds to pay for any overages above that amount required to implement the sewer project as proposed.

<u>SECTION 3.</u> That Joe L. Smith, in his capacity as Mayor, is hereby authorized and directed to execute all required documents to apply and implement the proposed project.

<u>SECTION 4.</u> That the City of Dadeville provide \$22,000 for the purchase of some materials to construct the new water improvements required for the expansion with the understanding that should water improvements require additional funds over estimated costs, these funds will be forthcoming from the Waterworks and Sewage Board of the City of Dadeville and they will be wholly responsible for providing water to the expanded industry.

WHEREAS, in order to create the jobs, SJA, Inc. requires water and sewer extensions to fulfill the requirements of the new facility; and
WHEREAS, the City of Dadeville will make application for grant funds to assist this much needed creation of jobs and to apply for assistance to the Alabama Department of Community Affairs (ADECA) for a Community Development Block Grant (CDBG) Economic Development grant in the amount of \$350,000.00 to finance the infrastructure construction; and
WHEREAS, the initial preliminary cost estimate estimated total project costs to be \$497,700 for both water and sewer improvements which is beyond the financial resources of the City at this time; and
WHEREAS, the Waterworks and Sewage Board of the City of Dadeville has been requested to assist with water improvements with an initial estimated cost of \$92,600 using local resources and in-kind labor plus costs for engineering, inspection and stormwater permitting, and
WHEREAS, the City has agreed to provide \$22,000 to assist with the purchase of materials for the water portion of the improvements needed and to move forward with the grant request for \$350,000 and to provide matching funds in the amount of \$33,000 or an amount that will cover any overages from estimated costs to complete the construction of sewer only,
NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Waterworks and Sewage Board of the City of Dadeville
SECTION 1. That the Board hereby commits to constructing all water improvements to serve the KwangSung expansion and will be wholly responsible for all costs associated with the water portion of the expansion project with the exception of Section 2 below.
SECTION 2. That the City of Dadeville will provide \$22,000 for the purchase of materials to construct the new water improvements required for the expansion and will be wholly responsible for constructing the sewer improvements needed for the expansion.
SECTION 3. That should water improvements require additional funds over estimated costs, these funds will be forthcoming from the Waterworks and Sewage Board of the City of Dadeville.
SECTION 3. That, in his capacity as, is hereby authorized and directed to execute all required documents and to take all actions necessary implement the proposed project.
