NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dadeville, Alabama as follows:

1. That BETTY J. ADAMS received a majority of the votes cast for the office of COUNCIL DISTRICT 1 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2016.
2. That H. A. (DICK) HARRELSON received a majority of the votes cast for the office of COUNCIL DISTRICT 5 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2016.
3. That no candidate received a majority of the votes cast for the office of MAYOR, and that WAYNE SMITH and JIMMY F. GOODMAN received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 4, 2016, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.

4. That no candidate received a majority of the votes cast for the office of DISTRICT 2, and that BROWNIE CALDWELL and HAROLD GAMBLE received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 4, 2016, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
5. That no candidate received a majority of the votes cast for the office of DISTRICT 3, and that TENEESHIA GOODMAN-JOHNSON and KEVIN M. HALL received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 4, 2016, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
6. That no candidate received a majority of the votes cast for the office of DISTRICT 4, and that ROY MATHIS and TROY DAVIS received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 4, 2016, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.


