NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dadeville, Alabama as follows:


1. That **DARRYL HEARD** received a majority of the votes cast for the office of **COUNCIL DISTRICT 1** and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.
2. That **BROWNIE CALDWELL** received a majority of the votes cast for the office of **COUNCIL DISTRICT 2** and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.
3. That **TENEESHIA GOODMAN-JOHNSON** received a majority of the votes cast for the office of **COUNCIL DISTRICT 3** and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.

4. That **TERRY GREER** received a majority of the votes cast for the office of **COUNCIL DISTRICT 4** and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2020.
5. That no candidate received a majority of the votes cast for the office of **MAYOR**, and that **FRANK GOODMAN** and **WAYNE SMITH** received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 6, 2020, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.




