## RESOLUTION NO. 21-005

# A RESOLUTION OF THE CITY OF DADEVILLE, ALABAMA, TO PROVIDE FOR THE ORGANIZATION OF THE CITY COUNCIL

WHEREAS, the City of Dadeville, Alabama has recently held municipal election in which its Mayor and Council have been duly elected to serve a four year term beginning on the first Monday in November, 2020; and

WHEREAS, the City Council wishes to provide for the organization of the City Council; and

WHEREAS, the City Council wishes to establish the time and place of regular meetings of the City Council each month; and

WHEREAS, the City Council wishes to adopt the rules of procedure to be followed during the City Council's deliberations; and

WHEREAS, the City Council wishes to ratify the use of the present depositories; and

WHEREAS, the City Council wishes to <u>temporarily</u> appoint all current administrative officers and personnel of the City to continue in their respective duties pending such time as the City Council shall make permanent appointments; and

WHEREAS, the City Council wishes to provide for the allocation of funds and payment of expenses; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dadeville, Alabama, as follows:

- 1. Regular meetings of the City Council are hereby established to be held on the second and fourth Tuesdays of each month with Pre-Council beginning at 5:00 P.M. and Council Meeting starting at 5:30 P.M. at Dadeville City Hall, 265 N Broadnax Street, Dadeville, Alabama 36853.
- 2. Except as otherwise provided by ordinance and state stature, Robert's Rules of Order Newly Revised is hereby adopted as the rules or order of procedure to be govern deliberations and meeting of the City Council of the City of Dadeville, Alabama.
- 3. Use of present depositories of the City is hereby ratified. The following bank is designated as the depository of the City and is authorized to accept for deposit, to the account, of the City:

Any two (2) officers of the officers as specified on required signature cards shall be authorized to enter into the bank's checking account agreement and are authorized to sign checks, drafts, and others on said account, and said bank shall be authorized to honor all checks, drafts, and others so signed.
- 5. Any two (2) of the following officers, Mayor, Mayor Pro Tem, and City Clerk, with the authorization of the City Council, are authorized to borrow money from, pledge or convey any property as security to, discount or sell any note, account or other instrument to said bank and to

enter into any agreement with said bank in regard thereto on behalf of the City.

- 6. The City Clerk is authorized and directed to furnish said banks a certified copy of this Resolution and the names and specimen signatures of the persons from time to time whose names appear on the banks' signature cards, and that said banks shall be authorized to rely thereon until written notice to the contrary is received.
- 7. All current administrative personnel of the City shall <u>temporarily</u> continue in their respective duties, offices and positions until such time as the Council shall choose to make permanent appointments at a subsequent meeting of the Council.
