ORDINANCE 480 A

AN ORDINANCE AMENDING THE CITY OF DADEVILLE REZONING APPLICATION FEES, ORDINANCE 480, 2012

WHEREAS, property owners in the City of Dadeville who wish to request a change in the zoning classification that applies to one or more specific properties must complete a Rezoning Application form; and

WHEREAS, property owners in the City of Dadeville who wish to request a change in the zoning shall pay a fee upon submission of the Rezoning Application form; and

WHEREAS, the Mayor and Council of the City of Dadeville approved an increase in the Rezoning Application fee(s) in regular council meeting on the 28th day of September, 2021 after motion by Councilperson Roy Mathis, and seconded by Councilperson Darryl Heard; and

THEREFORE, the Rezoning Application fee(s) shall be charged as follows:

REZONING: RESIDENTIAL AND PLANNED DEVELOPMENT

Rezoning from any residential classification to any higher residential classification. Rezoning from any district to PD, Planned Development, is included in this classification.
