

RESOLUTION NO. 18-017

A RESOLUTION OF THE CITY OF DADEVILLE, ALABAMA TO ADHERE TO THE STATE OF ALABAMA CICT –
CONSTRUCTION INDUSTRY CRAFT TRAINING FEES EFFECTIVE OCTOBER 1, 2016

BE IT RESOLVED, by the City Council of the City of Dadeville, Alabama as follows:

WHEREAS, the State of Alabama, Department of Finance, Division of Construction Management, passed Chapter 355 – 10 – 1 - .0X effective October 1, 2016 that is known as CICT – CONSTRUCTION INDUSTRY CRAFT TRAINING;

WHEREAS, this State of Alabama law requires that a construction industry craft training fee shall be collected in the amount of one dollar (\$1) per each one thousand dollars (\$1000) of construction authorized on the issuance of any non-residential construction building permit issued by any county, city, town, or other political subdivision of this state to the prime contractor;

WHEREAS, the construction industry craft training fee shall be based on the total sum of the construction cost of all non-residential building permits issued by the entity on or after the first day of the month and up to the last day of the month. The construction cost shall be the amount stated on the building permit;

WHEREAS, the construction industry craft fee shall be calculated by multiplying the total sum of all non-residential construction cost as stated on the building permits for the month by .001 rounded down to the whole dollar value. The construction industry craft training fee shall be zero when the total sum of all non-residential construction costs is less than \$1000 for the entire month;

WHEREAS, the City of Dadeville Building Inspector issuing the permit shall be responsible for collecting the fee on the permit, and remitting the amount by the second Tuesday of every month to the City Clerk for payment to the Department of Finance, Division of Construction Management;

WHEREAS, fees shall be submitted by the 20th day of the month for all applicable non-residential construction permits issued in the previous month and the Building Inspector shall certify the Construction Industry Craft Training Fee Monthly Report Form;

WHEREAS, when no monthly fees are collected for non-residential construction permits, the Building Inspector shall certify on the Construction Industry Craft Training Fee Monthly Report Form as such and remit it by the second Tuesday of every month to the City Clerk;

WHEREAS, the Building Inspector shall provide to the City Clerk any and all fees and/or the Construction Industry Craft Training Fee Monthly Report Form for non-residential building permits that are required to be submitted to the State of Alabama Department of Finance, Division of Construction Management from December, 2016 through June, 2018;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Dadeville, Alabama does hereby approve **RESOLUTION NO. 18-017 CICT – Construction Industry Craft Training Act** as set forth by the State of Alabama, Department of Finance, Division of Construction Management, Chapter 355-10-1-.0X, Construction Industry Craft Training Fees (CICT) to collect the non-residential Construction Industry Craft Training Fee on the building permits, and submit monthly this fee and/or the Construction Industry Craft Training Fee Monthly Report Form. Motion to approve the Construction Industry Craft Training Fee for non-residential building permits was made by Councilperson Caldwell and second was made by Councilperson Harrelson. Motion carried, non-opposed.
