TODAY, EFFECTIVE IMMEDIATELY, IT HAS BECOME INCREASINGLY IMPERATIVE TO CLOSE THE FOLLOWING CITY FACILITIES TO THE GENERAL PUBLIC IN AN EFFORT TO PROTECT CITY STAFF AND CITY PROPERTY FROM THE EVER CHANGING SPREAD OF THE CORONAVIRUS (COVID-19):

PUBLIC LIBRARY	CLOSED

THESE CLOSINGS WILL REMAIN IN FORCE UNTIL AT LEAST APRIL 6TH, 2020.

EVEN THOUGH OUR DOORS ARE NOT OPEN TO THE PUBLIC, STAFF ARE STILL REQUIRED TO REPORT TO WORK DURING REGULAR WORK HOURS.

CITY COUNCIL MEETING TUESDAY, 3/24/20, WILL BE HELD, BUT WE ARE ASKING THE PUBLIC TO LIMIT ATTENDANCE; THAT OTHER MEANS WILL BE AVAILABLE TO THE PUBLIC FOR THE CITY TO COMPLY WITH THE OPEN MEETINGS ACT AS DIRECTED BY GOVERNOR IVEY. COUNCIL AND ANYONE ELSE PRESENT WILL COMPLY WITH SOCIAL DISTANCING DURING THE MEETING.

IT IS ASKED THAT EVERY DEPARTMENT EMPLOYEE REMAINS PROACTIVE AND VIGILENT TO USE EVERY PROTECTIVE MEANS AVAILABLE TO LIMIT EXPOSURE TO THIS VIRUS AT WORK AND AT HOME. THERE ARE NO CONFIRMED CASES IN DADEVILLE OR TALLAPOOSA COUNTY AT THIS TIME, BUT THAT COULD SWIFTLY CHANGE AT A MOMENT'S NOTICE. STAY SAFE, STAY HEALTHY. WE CANNOT LIVE IN FEAR, BUT WE DO NEED TO RESPECT THIS NEW VIRUS, AND TAKE EVERY PRECAUTION THAT WE CAN.
