

ORDINANCE No.: 444-C
AMENDING ORDINANCE 444

AN ORDINANCE TO ESTABLISH A FEE SCHEDULE FOR SMALL CELL TECHNOLOGY FACILITIES IN THE CITY OF DADEVILLE, ALABAMA AS ESTABLISHED BY ORDINANCE NUMBER 504

WHEREAS, on the 28th day of April, 2020 the City of Dadeville City Council in a regularly scheduled City Council meeting voted to adopt and approve Ordinance Number 444-C to enact new regulations that apply to placement of Small Cell Technology Facilities ("Facilities" as defined in Ordinance Number 504 and used herein) along public rights-of-way and on private properties within the City of ; and

WHEREAS, the regulations established in Ordinance Number 504 will be codified of the City of Dadeville Municipal Ordinances entitled "Telecommunications"; and

WHEREAS, Sections 2E and 3C of Ordinance Number 504 provide that certain fees be paid by personal wireless service providers or applicants in connection with the review of applications, initial issuance and annual reissuance of permits required to construct, place, maintain and operate Facilities in the City; and

WHEREAS, the City Council herein amends Ordinance Number 444-C to set forth the level of fees contemplated.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DADEVILLE, ALABAMA, That Municipal Ordinances Code Of Ordinances Be Amended To Include The Fees Set Forth In This Ordinance Number 444-C, As Follows:

SMALL CELL TECHNOLOGY FACILITIES FEE STRUCTURE

DESCRIPTION	FEE
Permits to Place and Operate Facilities on Public Right-of-Way	
Permit Application and Review Fee – Permits for the placement of Small Wireless Facility that are not poles, for up to five Small Wireless Facility	\$500.00
Permit Application and Review Fee – Each Additional Small Wireless Facility in Excess of the Above Initial Five Included in One Application	\$100.00
Permit Application and Review Fee – For Installation of a New Pole Together With the Mounting or Installation of an Associated Small Wireless Facility in the Right-of-Way	\$1,000.00
Annual License Fee for new Provider poles or ground mountings and any Small Wireless Facility initially installed by Provider, per site, per year, per permit	\$270.00
Annual License Fee for attachments of Small Wireless Facility to third-party poles, per site, per year, per permit	\$270.00


Permits to Place and Operate Facilities on Private Property	
Permit Application and Review Fee – The First Five Small Wireless Facilities Included in a Single Application	\$500.00
Permit Application and Review Fee – Each Additional Small Wireless Facility in Excess of the Above Initial Five Included in One Application	\$100.00

Section 2. Repealer. All ordinances or parts of ordinances heretofore adopted by the City Council of the City of Dadeville, Alabama that are inconsistent with the provisions of this ordinance are hereby expressly repealed.



If any part, section or subdivision of this ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this ordinance, which shall continue in full force and effect notwithstanding such holding.

Section 4. Effective Date. This ordinance shall become effective immediately upon adoption and publication as provided by law.






