

RESOLUTION NO. 23-011

CITY OF DADEVILLE MISCELLANEOUS EQUIPMENT AND VEHICLES NO LONGER NEEDED FOR PUBLIC OR MUNICIPAL PURPOSES

WHEREAS, The City of Dadeville, Alabama, has miscellaneous equipment and vehicles at the City Shop, located at 834 E Columbus Street, that is no longer needed for public or municipal purposes; and

WHEREAS, Section 11-43-56 of the Code of Alabama of 1975 authorizes the municipal governing body to dispose of unneeded personal property; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dadeville, Alabama as follows:


