

# ORDINANCE NO.: 454-A

## AN ORDINANCE AMENDING ORDINANCE 454 OF THE CODE OF ORDINANCES OF THE CITY OF DADEVILLE, ALABAMA AS IT PERTAINS TO COLLECTION OF GARBAGE FOR THE CITY OF DADEVILLE

**WHEREAS**, the City of Dadeville, having recently evaluated the projected cost associated with providing garbage pickup service to customers of the City of Dadeville, having determined that it has been and continues to be necessary from time to time to raise the garbage rates to recover the increase in cost for operating the garbage collection system and providing service to the customers; and

**WHEREAS**, this amended ordinance sets out the revised rate to be implemented for garbage collection beginning on accounts to be billed on August 1, 2023; and

**WHEREAS**, this rate is based upon currently available information regarding the historical and projected operation and maintenance cost, historical and projected capital cost, historical and projected revenues, and applicable environmental regulation. Accordingly, the proposed rate is subject to possible future adjustment as needed.

**NOW, THEREFORE**, be it ordained by the City Council of the City of Dadeville, Alabama as follows:

1. Garbage services provided to any establishment by the City shall be paid for monthly and shall be charged for in accordance with the following rate schedule:

The monthly customer charge for residential customers beginning with the August 2023 billing shall be \$28.00, and monthly thereafter until such time another rate adjustment is needed.


### Severance

2. If for any reason, any clause, sentence, section, subsection, or provision of this ordinance, or the application thereof to any person or circumstance is held invalid by operation of state or federal law, existing or promulgated in the future, such invalidation shall not invalidate the remaining valid provisions, and the valid provisions shall remain in full force and effect.
3. This ordinance shall become effective on August 1, 2023 upon its adoption and publication as required by law.
4. All ordinances or parts of ordinances in opposition and not in accord with this ordinance are hereby repealed.
