

Award to Contractor - **AAA General Contractors, Inc.** for Demolition and Clearance Activities
Community Development Block Grant (CDBG) Project No. LR-CM-PF-21-002

WHEREAS, the City of Dadeville, Alabama was awarded funding for Community Development Block Grant (CDBG) Project No. LR-CM-PF-21-002, under which the City of Dadeville, Alabama is implementing demolition and clearance activities to eliminate blight which includes the demolition and clearance of 15 (fifteen) dilapidated residential properties declared public nuisances and located within the corporate limits of the City of Dadeville, Alabama, and

WHEREAS, the City of Dadeville, Alabama did publicly post and request separate sealed bids from qualified general contractors for Demolition and Clearance Activities involving the City's Community Development Block Grant (CDBG) Project No. LR-CM-PF-21-002. Advertisements for Bids were published in the *Dadeville Record*: Thursday, February 22, 2024, and the *Alex City Outlook*: Wednesday, February 28, and Saturday March 2, 2024, and

WHEREAS, the City of Dadeville, Alabama did receive the lowest bid for Demolition and Clearance Activities from **AAA General Contractors, Inc.** submitted on 3/13/2024, which was evaluated and whose firm met all essential public notice criteria requirements, and whose proposal amount was within the approved CDBG grant Project No. LR-CM-PF-21-002 budget for said Demolition and Clearance Activities, and

WHEREAS, the award of this contract to **AAA General Contractors Inc.** for Demolition and Clearance Activities for CDBG Project No. LR-CM-PF-21-002 is in compliance with applicable Federal, State, and ADECA regulations, and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dadeville, Alabama as follows:


SECTION 1. That the City of Dadeville awards the contract for Demolition and Clearance Activities to **AAA General Contractors, Inc.** for CDBG Project No. LR-CM-PF-21-002 in the amount of:

\$114,700 (One Hundred Fourteen Thousand Seven Hundred Dollars)


SECTION 2. That Jimmy "Frank" Goodman, in his capacity as Mayor, is hereby authorized and directed to execute the Contract Agreement for Demolition and Clearance Activities between the City of Dadeville, Alabama and **AAA General Contractors, Inc.** for a fee not to exceed:

\$114,700 (One Hundred Fourteen Thousand Seven Hundred Dollars)


