AN ORDINANCE AMENDING ORDINANCE 480 OF THE CODE OF ORDINANCES OF THE CITY OF DADEVILLE, ALABAMA, AS IT PERTAINS TO AMENDING THE ZONING

WHEREAS, the City of Dadeville passed a comprehensive zoning Ordinance No. 480 on or about October 8, 2012;

WHEREAS, property located at 1296 S Tallassee Street, 7.241 acres to be rezoned from R-2 to C-2; and

WHEREAS, the description of the area is:

Commencing at the southwest corner of Section 8, Township 21 north, Range 23 east and run east along the south boundary of Section 8 a distance of 1678.10 feet to an iron pipe at the southeast corner of the southeast quarter of the southwest quarter; thence turn an angle to the left of 92 degrees 21 minutes and run north 05 degrees 00 minutes east a distance of 1283.46 feet to an iron pipe on the westerly right-of-way margin of Highway #49 and the point of beginning of the parcel herein described; from such point of beginning, turn an angle to the left of 81 degrees 00 minutes and run westerly a distance of 433.19 feet to an iron pipe; thence turn an angle to the right of 107 degrees 58 minutes and run northerly a distance of 500.0 feet to an iron pipe; thence turn an angle to the right of 72 degrees 02 minutes and run south 86 degrees 00 minutes east magnetic a distance of 464.60 feet to an iron pipe on the west right of way margin of Highway #49; thence turn an angle to the right of 107 degrees 58 minutes and run southwesterly along the west right of way margin of said Highway #49 a distance of 274.59 feet to a concrete highway right of way marker; thence turn an angle to the right of 04 degrees 29 minutes and continue along the west right of way margin of said Highway #49 a distance of 118.12 feet to an iron pipe; thence turn an angle to the right of 05 degrees 36 minutes and continue along said west highway margin a distance of 118.75 feet to an iron pipe and the point of beginning.

WHEREAS, the Dadeville Zoning Board has recommended this property at 1296 S Tallassee Street, 7.241 acres, be rezoned from R-2 to C-2;

NOW THEREFORE, be it ordained by the City Council and the City of Dadeville, Alabama, as follows:

That Ordinance No. 480 be amended and that property located at 1296 S Tallassee Street, 7.241 acres, be rezoned from R-2 to C-2.
